Dear Senior Student and Parent(s)/Guardian(s):

As a Senior student you are eligible to park on campus at Toms River High School East. In order to do so you must apply for a parking permit and obtain a parking sticker. To apply for your parking permit you will need to complete the registration at www.tomsriverhighschoolseast.weebly.com. This website will become available at 7:00 am on Tuesday, August 1, 2023. Once on the site, click "Seniors" and fill out the form in its entirety.

Please have the following information ready to complete the form:

- License
- License plate number
- Car Registration
- Car insurance
- Parking lot preference (Big lot or Small lot)

Once you have completed your registration, you can come into the main office, August 8th - August 30th 9:00am-11:00am (School is closed on Fridays), to obtain your parking sticker with your assigned parking spot number. **Parking passes will not be issued August 31st - September 8th.** Students without parking stickers will not be permitted to park on school property. After September 11th, students can obtain a parking sticker at any point in the main office.

Please make sure to have the following items with you:

- Parking regulation paper with parent/guardian signatures
- \$5
- No outstanding obligations (textbooks, library fines, lunch fines, etc)
- Graduation diploma order form (**SENIORS WILL NOT BE ISSUED A PERMIT UNTIL THEIR DIPLOMA ORDER FORM IS COMPLETED, SIGNED BY A PARENT/GUARDIAN & TURNED IN**)

Your parking sticker must be adhered to the back window of your car. It must be in the bottom left corner, if you have any questions regarding its placement please notify security the first week of school.

Contact Mrs. Hines in the main office if you have any questions or concerns. I look forward to working with you and your Senior student during this very exciting time!

Parking Regulations 2023-2024

- You may not park on school grounds after the first day of school without a parking permit and/or tag
- You will be issued one parking permit for which you are solely responsible for
- Replacement parking stickers may be issued at a cost of \$5
- Parking permits may not be transferred for any reason. Doing so may result in the loss of parking privileges for the remainder of the school year.
- You may only park in your designated senior parking space which corresponds to your permit number.
- Parking on school grounds is at your own risk. The Toms River Regional School District is not responsible for any theft or damage to vehicles.
- ***Parking in the faculty parking lot is prohibited.*** Violation of this may result in suspension from school and forfeiture of your parking permit for the remainder of the school year. Also, students may not use the faculty lot as a pick up and/or drop off location.
- Parking is permitted only within the delineated spaces. You may not park along any fence.
- The Security Officers are in charge of the parking lots and enforce parking regulations. Their directions must be obeyed at all times. Security Officers have the authority to revoke parking privileges for any violation.
- You must yield to pedestrians at all times.
- Speed limit is 10 mph unless posted otherwise.
- Loud noise emitting from vehicles is prohibited (ie music, horns, yelling)
- Any violation of N.J. Motor Vehicle Code will result in a citation from the Toms River Police Department.
- Any violation of parking regulations may result in the police being notified and/or summons being issued. Vehicles may be subject to tow at owners expense and parking privileges suspended or revoked.
- Any combination of three discipline referrals and/or lates to school may result in the loss of parking privileges on school property.
- Should your vehicle become disabled during the school day you must notify administration/security and make arrangements to remove it. No vehicles can remain in the senior parking lot overnight.
- Parking decal sticker must be present in the back window of the vehicle (bottom left corner of window)
- Parking is HEAD ON only in the Senior lot.

I have read, reviewed with my parent/child and understand all parking regulations. I/ (My child) will abide by these regulations and understand that any violation will result in the loss of parking privileges.
